We, the undersigned **oppose the application Number ZBA20-24-DN to rezone from Agricultural to Rural Residential** regarding 49 River Road in the County of Brant, the lands legally described as TRACT BURTCH PT LOT 86 RP 2R-3708 PART 1.

We are opposed to enabling the severance of the existing single detached dwelling on 49 River Road, resulting in the creation of one (1) new residential lot.

16-49 River Road was purchased with the knowledge the land was zoned as Agriculture and good faith should be to maintain this designation.

One residence is already established on the land at 49 River Road. Severing of the land may have the potential for future owners to sever and further development of the land into multiple residences if rezoned as Rural Residential.

Much of the land of 49 River Road is designated as Natural Heritage Zone. Natural Heritage Zones provide conservation of the land for erosion control, protection of natural water sources existing underground and the surface. Development of a new residential lot may disrupt land conservation along with the habit and movement of wildlife in the natural corridor of the ravine and stream contained within land of 49 River Road.
