

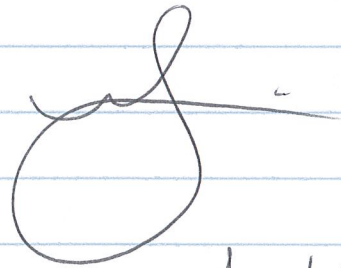
RE: 160 KING ST - ZYLSTRA.

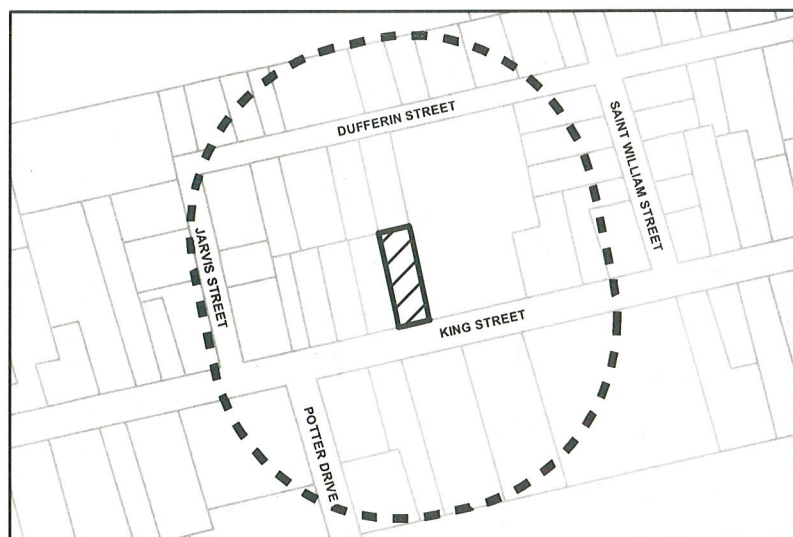
