7. Staff Reports

7.1 <u>RPT-21-134 - 2021 First Quarter Variance Report for Paramedic Services - H.</u> Mifflin

In response to questions, Russ King, Chief - Brant-Brantford Paramedic Service, updated Committee on forthcoming agreements for COVID-related expenses and vaccination staffing. Mr. King outlined that vaccination clinics are being staff through additional shifts, being back-filled with part-time staff, similar to an additional vehicle.

7.2 RPT-21-135 - Paramedic Services Statistical Report - R. King

in response to questions, Mr. King noted that per-patient tracking of offload times is expected to be available within the year. He further noted that the 26,000 calls for service, is a year-long projection. Mr. King highlighted various initiatives to reduce the number of patients delivered to the emergency department, including long-term care programs, extended authorization for paramedic services and inhome care. Mr. King reviewed that with an anticipated increase in calls after COVID-19 restrictions have been lifted, calls for service are expected to exceed projections.

7.3 RPT-21-136 - Paramedic Services COVID-19 Services Update

Mr. King updated Committee on operational adaptations to changing COVID-19 protocols. He noted a 2.95% reduction in call volume from previous years, offload times their lowest in six (6) years, less cross-border responses in the County and less Code Zero incidents. Mr. King commented on assistance with vaccine clinics throughout the summer and noted that the County's assistance with COVID patient transfers is no longer needed at this time.

In discussion, it was noted that next week is Paramedic Services Week and Committee members expressed appreciation for the service and the paramedics.
