Shang-Chi has superb opening

Shang-Chi and the Legend of the Ten Rings opened with an impressive US\$71.4 million at the North American box office. The film starring Canadian Simu Liu is set to rack up \$83.5 million over the four-day holiday weekend, eclipsing early projections of a \$50-million haul. It's the second-best U.S. debut during the pandemic, after Black Widow's \$80.3-million opening in July. Unlike that film, Shang-Chi was not available on streaming services, but played only on theatre big screens. Shang-Chi also set a new record for movie openings over the Labour Day weekend.

Dune earns mixed reviews

Critics gave the movie remake of science-fiction epic Dune mixed reviews after its debut at the Venice Film Festival on Friday. The film hits theatres and the HBO Max streaming service on Oct. 22. It's adapted from Frank Herbert's 1965 novel, which was made into a heavily panned 1984 film directed by David Lynch. Denis Villeneuve helms the new movie. It "earns five stars for world-building and about two-and-a-half for storytelling," said Variety film critic Owen Gleiberman. "It's not just that the story loses its pulse. It loses any sense that we're emotionally invested in it."
