The County Planner has forwarded me your email. I will attempt to answer some of your questions, prior to the County of Brant meeting.

As you are aware, a virtual open house was held by LandSquared at a virtual public meeting held by the County. Additional information has been provided to the Planner. This next meeting is when Planning and Development Committee will consider "support" or "no support" for the proposed tower. The final decision is with ISED. There are no appeal opportunities.

LandSquared has looked at alternative locations and has determined that the proposed location is the best in order to obtain coverage and to avoid the natural heritage feature. LandSquared is also willing to reduce the height of the tower to 60m which will reduce the required setback.
