Report

Background

The *Emergency Management and Civil Protection Act (EMCPA)* requires each municipality to comply with several legislated requirements to ensure the municipality has an emergency Management Plan in place to identify hazards that may impact the community and to take steps to mitigate, prevent, prepare for, respond to, and recover from these hazards.

The Emergency Management Division of Community and Protective Services is guided by our Emergency Management Program Committee, a committee comprised of key senior municipal leaders and supporting agencies. The Emergency Management Division is staffed by a parttime Community Emergency Management Coordinator (CEMC) who is tasked with ensuring our municipality's compliance with the EMCPA legislation. The CEMC works closely with our municipal staff and supporting community partners to ensure their operational readiness for the identified hazards and tests the Emergency Response Plan by conducting an annual emergency exercise.

The table below outlines the Emergency Management Program compliance objectives completed by the County of Brant's Emergency Management Program Committee in 2022.

The exercise was focused on evacuation processes as a result of a fictitious scenario that related to a hazard identified in the HIRA.
Emergency Information Officer (EIO)	Yes	As identified in By-law 63-21	The County of Brant's Emergency Management Plan appoints this position and defines the Emergency Information Officer's roles and responsibilities.
