7.1 Brant County OPP Detachment Commander's Report

Congratulations were extended to Inspector Quenneville on her promotion to Inspector, and her assignment in Brant. Inspector Quenneville acknowledged the desire for commitment to Brant and her anticipation to work together in the years ahead.

Inspector Quenneville presented the Detachment Commander's Report for July and August 2022. Discussion was held on the following:

• Correction was noted: Drug Crime shows a decrease in June and year-to-date 2022 (80% and 53.8% respectively), should read July.

- Stolen vehicle increase trend was noted. Inspector Quenneville reviewed data analysis, vehicle recovery, investigations, cross border/county activities, warrants issued and deterrent methods.
- School Resource Officer review by the Grand Erie District School Board timeframes are unknown. The Chair and Mayor will send letters of support for the program.
- Decrease of foot patrol hours was noted. Discussion was held with regards to the focus of officers, recording/capturing of time, and visual increase of officer presence noted.
