BY-LAW NUMBER 138-23

THE CORPORATION OF THE COUNTY OF BRANT

To provide for the collection of costs of repairs and maintenance of municipal drainage works in the County of Brant.

WHEREAS pursuant to Section 74 of the Drainage Act, R.S.O. 1990, D.17, the local municipality shall maintain and repair any drainage works constructed under the provisions of the said Act at the expense of all of the upstream lands and roads in the proportion determined by the then current by-law;

AND WHEREAS pursuant to Section 75(3) of the Drainage Act, R.S.O. 1990, D.17, the Council of any municipality shall not be required to assess and levy the amount charged for maintenance or repair of a drainage works more than once in every five years, if the total incurred does not exceed the sum of \$5,000.00;

AND WHEREAS such maintenance and repair work has been carried out on certain drainage works within the County and neighboring municipalities;

AND WHEREAS the Council of The Corporation of the County of Brant deems it expedient to assess and levy the costs of such maintenance and repair on the upstream lands;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF BRANT HEREBY ENACTS as follows:

 THAT the costs and charges for the maintenance and repair of municipal drainage works within the County of Brant shall be assessed and levied in accordance with Schedules "1" to "28" inclusive, attached hereto and forming a part of this By-law, being:
