7. Staff Reports

7.1 RPT-0545-24 2025 County of Brant O.P.P. Detachment Board Budget

Cindy Stevenson, General Manager of Emergency & Protective Services presented RPT-0545-24, 2025 County of Brant O.P.P. Detachment Board Budget. She noted an additional \$2,500.00 allocated to Training and Development to reflect the additional community representative and two new board members, and an additional account for postage related to the Brant Dispatch Newsletter. C. Stevenson further advised of a proposed one-time fund within the draft budget to sponsor the 2025 Special Olympics, with a similar request being sent to the Brantford Police Services Board. She noted a significant portion of the 2025 increase is due to the new structure and requirements of the new Board under the new *Community Safety and Policing Act*, with the remaining increase from the proposed sponsorship of the 2025 Special Olympics and the increase to the Training & Development account.

In response to questions, C. Stevenson advised that the 2024 Brant Dispatch Newsletter will be mailed out to residents at the end of the week of December 16th and the cost of postage will be reflected within the 2024 budget. She further noted that the Holiday Appreciation budget line was updated to reflect to the cost incurred in 2024. In response to further questions, C. Stevenson advised that the funding opportunities within the budget are specific to the County of Brant O.P.P. Detachment Board, with the exception of the 2025 Special Olympics in which the County of Brant will also be supporting. She advised that following Board approval, the budget will move forward to County of Brant Council for review and approval.

Discussion was held surrounding alternative methods of distribution for the Brant Dispatch Newsletter, with suggestions offered of providing physical copies at County of Brant facilities and online publication.
