

BY-LAW NUMBER 36-25

- of -

THE CORPORATION OF THE COUNTY OF BRANT

To establish fees and charges to be collected by the Corporation of the County of Brant for 2025

WHEREAS Section 391 of The Municipal Act, 2001, S.O. 2001, c. 25, as amended authorizes a municipality to impose fees or charges on persons;

AND WHEREAS pursuant to Section 69(1) of The Planning Act, being Chapter P.13, R.S.O., 1990, as amended, Council may prescribe a tariff of fees for the processing of applications made in respect of planning matters;

AND WHEREAS pursuant to Section 7 of The Building Code Act, 1992, S.O. 1992, c. 23, as amended, Council may require the payment of fees on applications for and issuance of building permits and prescribing the amounts thereof;

AND WHEREAS the Corporation of the County of Brant deems it expedient to consolidate and update the fees and charges to be collected by the various Departments and Boards of the Corporation of the County of Brant;

NOW THEREFORE THE CORPORATION OF THE COUNTY OF BRANT HEREBY ENACTS as follows:

1. **THAT** the fees and charges described in the attached Schedule "A" are hereby imposed in respect of:
 - a. services or activities provided or done by or on behalf of the municipality;
 - b. costs payable by the municipality for services or activities provided or done by or on behalf of any other municipality or local board; and
 - c. the use of the property of the municipality, including property under the control of the municipality.
2. **THAT** the fees and charges described in Schedule "A" shall be paid by the person or persons who have requested, received or obtained a service, activity or use of property identified in the Schedule.
3. **THAT** the fees and charges described in Schedule "A" shall be paid in cash or by such other means as may be approved from time to time by the Treasury Department.
4. **THAT** unless otherwise specified in Schedule "A", the fees and charges shall be paid in full at the earlier of the following times:
 - a. at the time the service, activity or use of property is received or obtained.
 - b. at the time the service, activity or use of property is requested.
5. **THAT** any portion of a fee or charge that remains unpaid beyond the date fixed for payment shall bear interest at the rate of 1.25% after thirty (30) days and each month thereafter until such fee or charge is paid in full.

6. **THAT** By-law Numbers 125-23, 139-23, 18-24, 26-24, 42,24, 73-24, and 119 -24 and all other by-laws and parts of by-laws setting out fees and charges which are inconsistent with the provisions of this by-law are hereby repealed when this by-law comes into effect on January 1, 2025, except as noted otherwise in Schedule "A".

READ a third time and finally passed in Council, this 25th day of March, 2025
