4. Delegations / Presentations

4.1 Mark Maxwell - Bawcutt Centre Restoration Project Update

Mark Maxwell, Director of Engineering & Infrastructure Planning appeared before the committee and provided an update on the Bawcutt Centre Restoration Project. He advised that the proposal is to proceed with the same conservation plan that has previously appeared before the Committee and Council, and that staff intend to return to Council with a plan for moving forward with the restoration as a standalone project. M. Maxwell noted that some interior restoration work may be deferred until the facility use is known, and that all exterior restoration work would proceed, pending Council approval.

In response to questions and concerns regarding the temporary wrapping on the Bawcutt Centre roof, M. Maxwell advised that the roof is inspected as regularly as possible, and that if the roof is not restored prior to winter, another wrap will be installed. He further advised that an approximate timeline for the project tender to come forward would be three months.

4.2 <u>Cate Breaugh - Paris Museum and Historical Society - Hiram Capron Homestead</u>

Cate Breaugh, Chair of the Paris Museum and Historical Society appeared before the Committee and requested that the Brant Heritage Committee protect and preserve the Hiram Capron Homestead, noting that it has come to their attention that the property may have been sold. They acknowledged that the Hiram Capron Homestead is a formally designated property and requested that the interior of the property be documented.

property, the ACHO will be alerted, and full review, including a grace period, must be brought forward to the Committee for endorsement, and afterwards to Council for approval.
